# Key responsibilities and duties

- Provide pitch side first aid cover at designated weekend academy fixtures.
- Provide pitch side cover at academy coaching sessions
- Carry out on pitch and pitch side assessments and deliver appropriate treatment to injured players.
- Liaise with the Academy coaching team and Academy medical staff regarding the medical status of Academy players and any injuries sustained during games.
- Liaise with Parents to pass on any relevant medical information concerning athletes under your care.
- Communicate effectively with all team members regarding squad availability, injury status and rehabilitation progress.
- Report back to the Head of Academy Medicine regarding assessments and treatment provided.

### Health and safety

- Fully endorse, demonstrate and carry out the company's health and safety policy.
- Comply with all company policies and statutory regulations relating to health and safety, safe working practices, hygiene, cleanliness, fire and COSHH. This will include your awareness of any specific hazards in your work place, and assist if required with the amending of risk assessments periodically.
