### What we process and share

The personal data which we may process about you as a candidate for employment has been collected from you, or has been received from third parties such as employment agencies. It may include your:

- name
- date of birth
- residential address and address history
- contact details such as email address and telephone numbers
- financial information
- employment history details
- photograph
- academic information
- right to work
- health screening results

When we process your personal data, we do so on the basis that we have a legitimate interest in the recruitment of suitable employees or workers, to verify identity, to protect the business and to comply with laws that apply to us. Such processing may also form part of the contractual relationship between us.

If you are successful in your application, and take up employment with us, we will retain your details. If you are unsuccessful we will retain your details for 12 months for potential future opportunities.

# Consequences of processing

Candidates who take up employment with Port Vale Football Club may have their details checked against DBS and credit reference databases.

Should our investigations identify adverse findings for a candidate when applying for, or during the course of your employment with us, this may influence our decision to offer or continue employment.

### **Data transfers**

The Information provided in an application for employment will be used to process your application. It will not be passed to third parties or used for other purposes other than as described above.

The information will be accessed and processed by us from within the EEA.
